07-02-2022 (Monday)	All PG degree programs in the faculties of Arts / Science / Commerce / Management / Education and All UG & PG programs in the Faculty of Health Sciences (BAMS / MD / MS) which already started functioning as per NCISM norms.
14-02-2022 (Monday)	All UG degree programs in the faculties of Arts / Science / Commerce / Management / and all Part-Time UG / PG Engineering programs.
07-03-2022 (Monday) (Tentative)	All UG degree programs in Engineering & Technology as per schedule to be released separately.

It is to be noted that the above physical reopening is strictly for conducting academic sessions inside the university premises in the interest of students following SOP protocols as notified by the UGC/AICTE/Govt. of TN. All the students are instructed to make their own arrangements for reaching the University premises.


