

NOW THIS UNDERTAKING-CUM-INDEMNITY WITNESSETH AND IT IS HEREBY AGREED AND UNDERTAKEN BY THE PARTY AS FOLLOWS:

In consideration of HMIL agreeing to donate Equipments, as detailed in the schedule to Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya at the request of The Registrar, Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya hereby agrees, undertakes and indemnifies HMIL as follows:

- a) Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya fully undertakes that the Equipments donated by HMIL will be used only inside the premises of Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya, Enathur, Kanchipuram-631561, Tamilnadu or the limited purpose of demo to impart effective training to the students of Department of Electronics and Instrumentation Engineering to learn the latest technologies and will not be used in any other place including on road, for any purpose whatsoever including commercial purpose.
- b) Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya further undertakes that the Engines donated by HMIL will not be fixed or used in any vehicles intended for any purpose including transportation of any kind of whatsoever nature on any road and within premises of Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya, Enathur, Kanchipuram-631561, Tamilnadu



- d) Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya would be fully responsible and liable and shall indemnify and keep HMIL indemnified from and against all expenses, costs, damages, losses, etc., that HMIL may suffer or be put to as a result of breach of this Undertaking committed by Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya violation of any laws, rules & regulations as may arise on account of use of Equipments by Sri_Chandrasekharendra Saraswathi Viswa Mahavidyalaya or any injury/accidents caused to any persons during demo and also as long as when the Equipments are kept within the premises of Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya or any road accidents resulting in loss of lives or damages to any third party, property or other reasons.

This Undertaking-cum-Indemnity shall be in full force and operation until the Equipments are fully dismantled.
