SCSVMV-TBI RULES & REGULATIONS FOR INCUBATEES

- The incubatee will be permitted to register only if the idea proposed is innovative, relevant and/or commercially viable. Novelty in the form of (a) utilization of un-utilized or underutilized raw materials, (b) green technology (c) value additions with scope for establishing in market, (d) energy saving models, (e) process variations (f) uniqueness in product or its use pattern (g) innovative strategies in implementation, (h) low cost solutions (i) alternative & socially sensible services (j) industry specific problem solving etc only will be normally accepted for registration.
- 2. Full payment of incubatee registration fee of Rs. 5000 (no change since 2008) will make the incubatee eligible for office space & lab/ workshop use rights.
- 3. Potential incubatees (not yet developed clean inclination for start-up or are not convenient in opting for full fledged registration but remain potent in terms of strength of idea) are provided with limited support as pre-incubation services. Nominal fee towards registering (pre registration) considered. Proof-of- concept encouraged with intermittent usage of facilities, networking support (to an extent) etc., from TBI.
- 4. For lab use & office space use rentals are to be paid by the incubatees & potential incubatees as per the established guidelines in place for the same. This can be remitted in quarterly basis for instance. A few concessions can be issued (as motivational components) to most promising pre-incubation / incubation works based on merit, specialty of the idea realization patterns etc.
- 5. Incubatees get preferences / consideration on various TBI initiatives through.
 - (a) Strength of the innovation idea incubated
 - (b) Rate of progress shown by the incubatee
 - (c) Innovativeness in implementation & output of incubation.
 - (d) Right conduct & focused activities
 - (e) Domain specificity
 - (f) Progress as evaluated by officials
 - (g) Social commitment & B savvy approaches
 - (h) Genuine perseverance
- 6. If the incubatee requires any reference letter from TBI, they shall
 - (a) Produce a written request letter with details thereon.
 - (b) Basing on the merit of the content provided & expert opinion on the same, reference letter is given shape.
 - (c) Recommendation for secondary funding or seed funding is initiated for specific ideas under available govt. schemes or authorized firm sponsored programmes by TBI time to time. Selection will be through screening by managing committee or screening committee for the same.
- 7. For un-announced schemes, letter is issued only for introduction as an incubatee with matter-of-fact info on incubation at TBI. Recommendation and/ or shouldering of the financial responsibilities in whatsoever format is **not** in the scope of the incubation centre.

- Incubation supports are being extended in the TBI facility normally during SCSVMV office hours in all working days. Extended activities, if any, by the incubatee can be entertained only on merit basis & upon obtaining permission from higher-ups as per prevailing rules in the campus.
- 9. Incubation facilities extended shall be used only for the intended purpose. TBI brand could be used by incubatees after intimating the same in written form.
- 10. Exit policy is based on facts such as
 - (a) Tenant period (2to 3years)
 - (b) Extended marketing of products
 - (c) IPR & Marketing by tenant
 - (d) Sustenance in Business
 - (e) Meeting the incubation milestones
 - (f) Failure to do so repeatedly
