

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is made and entered into on this 10.04.2024, by and between:

Sri Chandrasekharendra Saraswathi Viswa Mahavidyalya, a deemed to be University located at Jayendra Saraswathi Street, represented by Dr.G.Sriram, Registrar, (hereinafter referred to as the "University")

And

Sri Sankara Multispecialty Hospital, a hospital located at Enathur, Vaiyavoor Road, Konerikuppam represented by Mr. Nandhakumar, Executive Officer, (hereinafter referred to as the "Hospital")

Collectively referred to as the "Parties."

Background:

The Hospital is a renowned healthcare facility providing various medical services to the community. The University is an esteemed institution offering courses in allied health sciences, aiming to provide quality education and training to its students from various socio-economic backgrounds.

Purpose:

The Parties wish to collaborate to provide practical training and clinical exposure to the students of the University.

Terms of Collaboration:

1. Hospital Facility Usage: The Hospital agrees to allow the students of the University to use its facilities for clinical training and practical sessions, subject to the availability of resources and scheduling arrangements.
2. Duration: This MoU shall be effective from the date of signing and shall remain in force for a period of 4 years, unless terminated earlier by mutual agreement of the Parties.




Responsibilities:

1. The Hospital shall provide necessary infrastructure, equipment, and resources for the training of the students.
2. The University shall ensure that its students adhere to the rules and regulations of the Hospital during their training period.
3. Both Parties shall appoint a liaison officer to facilitate communication and coordination between them.
4. Confidentiality: The Parties agree to maintain the confidentiality of any patient information or other sensitive data they may have access to during the collaboration.
5. Intellectual Property: Any intellectual property developed during the collaboration shall be jointly owned by the Parties unless otherwise agreed in writing.
6. Termination: Either Party may terminate this MoU by providing a written notice of 90 days to the other Party.

General Provisions:

1. This MoU constitutes the entire understanding between the Parties and supersedes any prior agreements or understandings, whether written or oral.
2. This MoU may be amended or modified only in writing and signed by both Parties.
3. The jurisdiction of the agreement shall be within the courts in Kanchipuram.
