

**MEMORANDUM OF UNDERSTANDING
(MoU)**

Between

**KASERSART UNIVERSITY
The Kingdom of Thailand**

And

**SRI CHANDRASEKHARENDRA SARASWATHI VISWA MAHAVIDYALAYA-
SCSVMV DEEMED UNIVERSITY
Republic of India**

The universities, wishing to promote co-operation in education and in academic research, agree as follows:

**ARTICLE I
OBJECTIVE(s)**

The objectives of this Memorandum of Understanding is to establish collaborative research between the two institutions.

**ARTICLE II
SCOPE OF ACTIVITIES**

Academic cooperation will include, subject to the availability of funds and the framework of the regulations and administrative rules in force in each country:

- 1) Exchange of faculty members and staff;
- 2) Exchange of undergraduate and graduate students;
- 3) Joint research activities;
- 4) Joint teaching programs;
- 5) Participation in seminars, meetings, and academic conferences;
- 6) Exchange of academic materials and other information;
- 7) Special short-term academic programs; and
- 8) Other activities based on mutual interest.

ARTICLE 3
FUNDING

Both universities will attempt to provide part of the finance necessary for the implementation of the present agreement, and will apply for the award of specific funds, within other bilateral programs or multilateral programs.

ARTICLE 4
IMPLEMENTATION

Both universities will consult each other whenever it is considered necessary, and will prepare an annual report of all actions implemented and underway.

A liaison officer will be designated by each university to promote and coordinate cooperation.

ARTICLE 5
EQUALITY AND NONDISCRIMINATION

Both universities subscribe to a policy of equal opportunity and nondiscrimination

ARTICLE 6
INTELECTUAL PRPERTY

In case of results obtained within the framework of joint programs, as defined in separate contracts, no university may register a patent or exploit the results commercially without the written consent of the other.

Whenever possible, the patents will be jointly registered by both universities.

If one relinquishes its rights, or does not respond within ninety (90) days, the other is entitled to register the patents in its own name.

The publication or the free exchange of scientific results jointly obtained cannot take place without a mutual agreement between the two partners, especially if the nature of the program has been defined as confidential.

ARTICLE 7
SETTLEMENT OF DIFFIERNCES

Any disputes arising from this agreement will be settled in a amicable way.

ARTICLE – 8

AMENDMENTS, DURATION AND TERMINATION

This Memorandum of Understanding (MoU) is agreed for a period of five (5) years and effective from the date the representatives of both Universities affix their signatures below. At the end of this period, in the event of renewal, it will be again subject to the procedure of communication.

It may be revised through the mutual agreement of both Universities, and can be terminated by one of the Universities upon giving six months' written notice signed by the presiding officer of the notifying party. Notification of termination can be made any time.

This Memorandum of Undertaking (MoU) is signed in two copies in English.


