**ORDER**

Vide paper read as (1) above, Ms. Sreeparvathy Viswanath submitted application under Fast Track mode to grant equivalency to B.Ed with Pedagogy subjects Sanskrit & Sanskrit programme under regular mode offered by Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya (Deemed to be University) with B.Ed Sanskrit programme of the University of Calicut.

As per paper read as (2) above, the Board of Studies in Education UG remarked that, considering the request of Ms. Sreeparvathy Viswanath regarding equivalency to B.Ed with Pedagogy subjects Sanskrit & Sanskrit programme under regular mode from Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya (Deemed to be University) with B.Ed Sanskrit programme of the University of Calicut, the Equivalency certificate in B.Ed Sanskrit can be issued to the applicant. The Board of Studies members verified the documents submitted by the Ms. Sreeparvathy Viswanath and found out that the candidate has degrees in BA Sanskrit and MA Sanskrit, and meets the eligibility criteria for admission to B.Ed Sanskrit in the University of Calicut. There is similarity between the scheme and syllabus of B.Ed programmes of both University as prescribed. The Board of Studies recommended that, Equivalency certificate can be issued to B.Ed with Pedagogy subjects Sanskrit & Sanskrit programme under regular mode from Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya (Deemed to be University) with B.Ed Sanskrit programme of the University of Calicut for the applicants meeting similar eligibility criteria.

As per paper read as (3) above, the Dean, Faculty of Education approved the above recommendation of the Chairperson, Board of Studies in Education UG.
