# **Step-by-step procedure**

# to fill out online anti-ragging undertaking affidavit form

(July 2024 as per UGC guidelines)

### Preamble:

Ragging is defined as any disorderly conduct, whether by words spoken or written or by an act, that has the effect of teasing, treating, or handling with rudeness a fresher or a junior student. Indulging in a rowdy or undisciplined activity that causes or is likely to cause annoyance, hardship, or psychological harm or to raise fear or apprehension thereof in a fresher or junior student.

### UGC Regulations on curbing the menace of Ragging in Higher Educational Institutions, 2009

Ragging is a criminal offense and UGC has framed regulations on curbing the menace of ragging in higher educational institutions to prohibit, prevent and eliminate the scourge of ragging. In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, in the exercise of the powers conferred by clause (g) of sub-section (1) of section 26 of the University Grants Commission Act, 1956, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009". These regulations are mandatory for all universities/ institutions.

### SCSVMV Anti-Ragging Squads Committee (ARSC)

The Anti-Ragging Squad Committee office bearers engage in checking places like hostels, buses, canteens, grounds, classrooms and other places of student congregation to keep a vigil and stop the incidences of ragging, if any, and report them if they happen. The squad role is also to educate the students at large by adopting various means about the menace of ragging and related punishments there to.

### Students and Parents Undertaking Affidavit

In compliance of the second amendment in UGC Regulations, it is **compulsory for each student** and every parent to submit an online Anti-Ragging undertaking affidavit every academic year as part of eradicate the ragging. Link to fill out the online undertaking affidavit by students and parents:



**Step 1:** Link to fill out the online undertaking affidavit by students and parents: www.antiragging.in/affidavit\_registration\_disclaimer.html





After filled all required fields, you need to click on Next button.


Step 6: You need to check and click all the checkboxes, then click on Submit Button.




Step 7: Fill the Confidential Survey
