MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is entered into on this 26th day of February Two Thousand Twenty Five

By and Between

Sri Chandrasekharendra Saraswathi Viswa Mahavidyalaya (SCSVMV)

Enathur, Kanchipuram, Tamil Nadu, India

and

Hand in Hand Academy for Social Entrepreneurship (HIHA),

an organisation head quartered in Chennai, Tamil Nadu, India

Both parties recognize the value of collaboration in the fields of social entrepreneurship, skill development, and academic growth, and are committed to working together in a spirit of mutual respect and benefit.



Objectives of the MoU

The objectives of this MoU are:

- Conducting faculty development programs in relevant fields.

3. Research and Development:

- Supporting joint research initiatives, publications, and case studies.
- Sharing resources, tools, and frameworks to enrich research and academic outcomes.

4. Community Outreach:

- Collaborating on initiatives that directly benefit local communities through sustainable development projects.
- Promoting awareness of entrepreneurship and social innovation among stakeholders.



Financial Arrangements

This MoU does not entail any financial obligation for either party. Each party will bear its own costs for activities undertaken under this collaboration unless specifically agreed upon in writing by both parties.

Validity and Termination

1. This MoU will be valid for an initial period of **three (3) years** from the date of signing, after which it may be reviewed and renewed upon mutual agreement.
2. Either party may terminate this MoU by giving **three (3) months' written notice** to the other party.

Dispute Resolution

Any dispute arising out of the implementation of this MoU shall be resolved amicably through mutual discussions between the parties.

General Provisions

1. This MoU is non-binding and does not create any legal or financial liability on either party.
2. Any amendments to this MoU shall be made in writing and signed by both parties.
